On Thursday, April 14, 2022, at 12:00 p.m., the Dubuque Metropolitan Area Transportation Study (DMATS) will hold a Public Hearing for approval of Draft Fiscal Year 2023 DMATS Title VI Non-Discrimination Program Plan and Draft Fiscal Year 2023 DMATS Limited English Proficiency (LEP) Plan.

The public is invited to submit their input. The Public Hearing will be held at East Central Intergovernmental Association, Community room, 7600 Commerce Park, Dubuque, Iowa. This facility is accessible under the provisions of the Americans with Disabilities Act. DMATS receives federal funding and may not discriminate against anyone on the basis of race, color, or national origin, according to Title VI of the Civil Rights Act of 1964. For more information or to obtain a Title VI Complaint form, call 563-556-4166. DMATS is open to all individuals regardless of disability. Any person with a disability requiring a reasonable accommodation to participate in this meeting should contact the DMATS office at (563) 556-4166 at least two business days prior to the scheduled meeting. The DMATS office will be closed to public due to COVID -19. Individuals who need to attend DMATS meeting physically should get in touch with DMATS staff one day before the meeting to updated staff on their attended. Staff will be asking questions before providing approval to attend the meeting.

The Title VI Non-Discrimination Program Plan is designed to address title VI regulations within DMATS area and Limited English Proficiency plan is designed to address how DMATS will accommodate non-English-speaking population in planning and decision-making process.
