IDOT recently completed it's 2022 Transportation Asset Management Plan (TAMP), and in doing so, has adopted new 2-and 4-year federally-required transportation performance measure targets for PM2: Asset Management and PM3: System Performance (see attached). Each MPO again has the option to accept the State's new targets or set their own by May 15, 2023, or 180 days after the targets were completed on 11/15/2022. Per the performance measures agreement the Department entered in with each MPO and urbanized public transit agency, action should be taken by your Policy Committee for accepting or setting your own targets.

For those wishing to set their own targets or review local performance, pavement and bridge condition information is available to download on our website at the following link under the performance tab: http://www.idot.illinois.gov/transportation-system/transportation-management/planning/tamp. The same data files include the expanded effort to provide asset condition data on all classified arterials and collectors. Certain system performance metrics can be accessed through the National Performance Management Research Data Set (NPMRDS) at the following link: https://npmrds.ritis.org/analytics/.
