This facility is accessible under the provisions of the Americans with Disabilities Act. The TPWP is prepared and adopted each year and contains transportation planning activities for the current fiscal year. The Title VI Non-Discrimination Program Plan is designed to address title VI regulations within RPA 8 area and Limited English Proficiency plan is designed to address how RPA 8 will accommodate non-English-speaking population in planning and decision-making

process. The PIP is developed in hopes that it will promote and encourage citizen involvement in the decision-making process.

The Draft FY 2021 TPWP, Draft FY 2021 Title VI Non-Discrimination Program Plan, Draft FY 2021 Limited English Proficiency plan and Draft FY 2021 Public Involvement Policy Plan are currently available for review at the office of the Regional Planning Affiliation 8, ECIA, 7600 Commerce Park, Dubuque, Iowa.
